- 2. No claim for seat due to late reporting or absentisem will be considered.
- 3. Candidates who have not applied online earlier will be offer admission after Personal Interview with respective associates from industries on the left out seats (If Any).
- **4.** All admission will be provisional until final verification of all eligibility criteria is made.
- **5.** On-the-spot counselling will be done according to the given schedule subject to Availability/ Vacancy after 2nd counselling is completed.
- **6.** The left outs seats after 2nd counselling will be converted to open seats for on-the-spot counselling if suitable candidates (category wise) are not found. Preference will give to those candidates who have applied online for the programmes.
- 7. Number of vacant seats may increase, if any cancellation of admission is reported.
