Documents required at the time of Interview

Please bring the following in support of your candidature:

1. Five set of documents consist of – Copy of Application, Copy of certificate and mark sheet of qualifying examination, Category certificate, Experience certificate with proof of salary (Bank statement/EPF No./NPS/GPF No./Form 16/PF statement without which experience certificate shall not be treated as valid document).
2. All the original documents in respect of eligibility, experience as claimed in the application form etc must be presented at the time of interview otherwise candidate shall not be allowed to appear in the interviews.
3. In case any applicants is employed in a Govt./Semi Govt./PSU and has not sent application through proper channel, they are required to submit No objection certificate from the employer at time of interviews otherwise they will not be allowed to appear in the interviews.
4. Valid ID proof with clear photograph (Aadhar card/Pan card etc., category certificate and income certificate if applicable).
5. Candidate who have submitted PG diploma as a qualification to claim as post Graduate degree are required to submit equivalency certificate from their respective institution/University in accordance with UGC/AICTE norms, at the time of interview.

6. Applicants for the post of Resident Medical Officer(RMO) are required to furnish their valid MCI/State Medical Registration certificates at the time of interviews failing which their candidature shall not entertained
7. Candidature for interview in respect of all the applicants is provisional subject to production of aforesaid documents for eligibility for the post, failing which they will not be allowed to appear before the establishment Committee for interview.
8. It is the responsibility of the candidate to ascertain his/her own eligibility for the respective post before appearing in the interviews. If any information is found to be incorrect at any stage during the selection process, the respective application will summarily be rejected.
9. No TA/DA would be admissible.
