- 4. The required qualification and relevant experience etc. for eligibility shall be determined as on the closing date.
- 5. The application fees shall be as under: -

The candidates belonging to the category of PH (PwD i.e. Person with Disabilities) will enclose necessary certificates with their application form from a Competent Authority in support of their claim of Disability. All such certificates should clearly mention the type of disabilities as defined inthe Govt. letter dated 25.04.2018.
- 7. Application fee to be paid through online mode & payment receipt shall be enclosed with the application form.
- 8. All qualifications must be attained from recognized Board/Universities/Institutes. The Candidates who have obtained qualifications from any Board/University/Institution declared fake or not recognized by respective regulatory bodies shall not be eligible for consideration for any of the post advertised. Qualifications obtained through distance mode are not admissible for teaching posts in science and technology.
- 9. If a Grade Point System is adopted the CGPA will be converted into equivalent marks. Provide the relevant document of conversion of CGPA into equivalent marks along with application form.
- 10. The prescribed essential qualifications and experience indicated are bare minimum and mere possession of the same will not entitle any candidate for consideration of Interviews
- 11. University may conduct written test/ skill test for shortlisting candidates if required.
- 12. The vacancy shown in advertisement is indicative and may increase or decrease at the discretion of the University at the time of selection. The University reserves the right not to Empanel the Guest faculty as advertised without assigning any reason.
- 13. No TA/DA is payable for attending interview.
- 14. As per Ministry of Human Resource Development Notification No. 44 dated 01-031995 published in Gazette of India edition dated 10-06-2015, the Degree obtained through open Universities/ Distance Education Mode needs to be recognized by Distance Education Council, IGNOU. Accordingly, unless such Degrees had been recognized for the period when the candidates acquired the relevant qualification, they will not be accepted for the purpose of Educational Qualification.
- 15. A candidate found ineligible at any stage of selection/norms his/her candidature will summarilybe cancelled no claim shall be entertained.
- 16. Concealment of facts or supply of wrong information will result in cancellation of candidature at any time in addition to legal action.
- 17. The Candidates are advised to keep on visiting the website of the University for related updates including any corrigendum/addendum, date of interview/ Result etc. Further, no information in respect of this advertisement shall be published in the newspaper.
- 18. Separate application form is required to be submitted for each post with prescribed fee on the date of interview.
- 19. Candidate will be allowed to appear for the Interview subject to scrutiny of application as per theeligibility/qualification criteria. Candidates found not eligible by the scrutiny committee or who donot produce original documents shall not be allowed to appear in interview.
