1. Candidate interested to take admission in any program must report physically on the date of open counselling between 9:00 AM to 12:00 Noon and ensure to sign the attendance sheet available at the reporting venue for consideration of candidature in that particular program.
2. The documents of the selected candidates will be verified by the duly constituted admission committee.
3. The candidate must read the prospectus 2025-26 carefully before attending the counselling.
4. The candidate must bring all relevant original documents in support of their educational qualifications and category as mentioned in the prospectus, along with two sets of self-attested photocopies of all the documents at the time of counselling.
