## PH.D. PROGRAM FOR 2020-21

I. Shri Vishwakarma Skill University invites application for admission to Doctor of Philosophy (Ph.D) for the following Skill Faculties for the session 2020-21

#### II. ELIGIBILITY CRITERIA FOR ADMISSION TO PH.D. PROGRAMME:

- 1. A candidate for admission to the course of Ph.D. program shall have Master's degree or a professional degree declared equivalent to the master's degree by the corresponding statutory regulatory body with at least 55% marks in aggregate or its equivalent grade B in the UGC 7 point scale (or an equivalent grade in a point scale where ever grading system is followed or an equivalent degree from a foreign educational institution accredited by an assessment and accreditation agency which is approved/recognized or authorized by an authority, established or incorporated under a law in its home country or any other statuary authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institution. The equivalence of the degree will be decided by the PG Board of Studies in the University.
- 2. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-able and other categories of candidates as per the decision of the Commission from time to time, or for those who had obtained their Master's degree prior to 19th September, 1991. The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.
- 3. Candidates who have cleared the M.Phil course work with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) and successfully completing the M.Phil. Degree shall be eligible to proceed to do research work leading to the Ph. D. Degree in the same Institution in an integrated programme. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/differently-abled and other categories of candidates as per the decision of the Commission from time to time.
- 4. A person whose M.Phil. dissertation has been evaluated and the viva voce is pending may be admitted to the Ph.D. programme of the same Institution. The candidates who appeared in regular master's level examination in the current session may also appear in the entrance test. But they must submit the proof of having passed the examination on the pre-designated date before admission to the Pre-Ph.D. course.
- 5. Candidates possessing a Degree considered equivalent to M.Phil. Degree of an Indian Institution, from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions, shall be eligible for admission to Ph.D. programme.
- 6. For Skill Faculty of Management : Master's Degree or any other degree recognized equivalent thereto in Business Administration or Economics or Commerce or in allied subjects or Two years Post Graduate Diploma in Management recognized as

equivalent to MBA by AICTE/AIU or Graduates having passed their final examination of the Institute of Chartered Accountants of India with 55% marks (50% for SC/ST candidates of Haryana) in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed).

The candidates who have qualified UGC-NET (including JRF)/UGC-CSIR NET (including JRF)/SLET/GATE/teacher fellowship holder or have passed M.Phil. programme will be exempted from appearing in the entrance test for Ph.D. Programme. However, they will have to appear in the interview as per schedule. The candidates who have qualified JRF (valid)/NET (Valid for two years from the date of issue of certificate) conducted by the UGC/CSIR/DBT/ICMR and ASRB. The condition of validity of duration of two years of issuance of NET certificate will not be applicable on the regular teachers working in State Universities/Central Universities and Govt./Govt. Aided Colleges. Regular teachers of SVSU and Foreign students are also exempted from entrance test but they need to apply before the due date with requisite fees to be considered for interview.

However, all are required to fill the application form along with the requisite fees.

An entrance test will be held for admission to Ph. D Programme on 24<sup>th</sup> Oct 2020.

## IV. HOW TO APPLY

The candidates interested in the above courses are requested to fill the entrance test registration form available on university website. Download and submit the filled application form along with self-attested copies of mark sheet (Matric onwards), Passport size photographs and a demand draft of Rs 1000/- (one thousand) in favour of **Registrar, Shri Vishwakarma Skill University, payable at Gurugram.** 

### V. Ph.D. ENTRANCE TEST

The candidates will be required to attempt 100 multiple choice questions, each question carrying 1 mark. The entrance test will include 50 questions of research methodology and 50 questions of the subject/Domain. The syllabus of the entrance test of each faculty will be uploaded on university website.

## VI. PERSONAL INTERVIEW

Eligible Candidates (qualified in the entrance test and exempted from entrance test) will be called for personal interview. The candidates are required to discuss their research interest/area through a presentation before a duly constituted Committee.

The interview shall consider the following aspects, viz. whether:

- a) The candidate possesses the competence for the proposed research;
- b) The research work can be suitably undertaken at the University
- c) The proposed area of research can contribute to new/additional knowledge.

Qualifying the test and interview will not entitle a candidate to claim for admission in the University. Final selection of the candidate will be subject to availability and consent of the research supervisor.
