Health Care (MLT)	A Master's degree with 55% marks in MLT OR MD/MS/MDS.
Health Care (Public Health)	A Master's degree with 55% marks in Public Health OR MD/MS/MDS.
German Language	1.A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign University. 2. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET in Linguistics or who have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET : As per UGC Regulation 2018.
Footwear Design	Bachelor's degree in Footwear design or a Diploma in any one of the streams of Footwear Design with three years' work experience,
Agriculture Sciences	1. Good academic record with at least 55% of marks or an equivalent grade at the Master or Doctorate level degree in a relevant subject of concerned faculty from recognized University. 2. The candidate should have passed NET examination conducted by UGC/CSIR/ICAR/NET recognized by the State Govt. in the subject, where, NET examination is conducted and should have published at least one article in National Academic of Agriculture Sciences (NAAS), New Delhi rated journal, but, the candidate who has acquired Ph.D. degree with course work as per the UGC Notification-2009 and published two full length publications having a NAAS rating not less than four shall be exempted from NET on the last date of submission of application. Those candidates with Ph.D. degree without course work will not qualify for NET exemption.

Instructions to the applicant

1. The Candidate must be citizen of India.
2. Good knowledge of computer applications will be a distinct plus.
3. The required qualification and relevant experience etc. for eligibility shall be determined as on the date of walk in interview
4. Relaxation of 5% marks shall be awarded for SC/ST candidates.
5. All qualifications must be from recognized Board/Universities/Institutes. The Candidates who have obtained qualifications from any Board/University/Institution declared fake or not recognized by respective regulatory bodies shall not be eligible. Qualifications obtained through distance mode are not admissible for teaching posts in science and technology. If a Grade Point System is adopted the CGPA will be converted into equivalent marks.
6. The prescribed essential qualifications and experience indicated are bare minimum and mere possession of the same will not entitle any candidate for empanelment. The applications may be short-listed on the basis as deemed appropriate by the Competent Authority.
7. University reserves the right not to empanel the post advertised without assigning any reason.
8. All empanelled Faculty shall be paid remuneration as per UGC norms during their engagement with University.
9. The classes under dual education model will be conducted both at University Campus and Industrial premises as per requirement of the course.
10. No TA/DA is payable for attending the interview for the posts.
13. In case, the candidates fail to bring originals and attach self-attested copies of testimonials, their application would not be considered.
14. Concealment of facts or supply of wrong information will result in cancellation of candidature at any time in addition to legal action.
15. The Candidates are advised to keep on visiting the website of the University for related updates including any corrigendum/addendum. Further, no information in respect of this advertisement shall be published in the newspaper.
