The eligibility is as follows:

<b>1</b>	<b>Guest Faculty in Economics</b>	<p>1. A. (i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.</p> <p>(ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/ SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/ Ph.D. degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/ SLET/SET;</p> <p><b>Provided</b>, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing ordinances/ Bye- laws/ regulations of the Institutions awarding the degree and such Ph.D candidates shall be exempted from the requirement of NET/SLET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities /Colleges/ Institutions subject to the fulfillment of the following conditions: -</p> <p>(a)The Ph.D. degree of the candidate had been awarded in a regular mode;</p> <p>(b) The Ph.D. thesis has been evaluated by at least two external examiners;</p> <p>(c) An open Ph.D. viva voice of the candidate has been conducted;</p>

		<p>(d) The candidate has published two research papers from his/ her Ph.D. work, out of which at least one is in a referred journal; The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.</p> <p>(e) Candidate has made at least two presentations in conferences/seminars, based on his/her Ph.D. work. Note: NET/ SLET/ SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET. OR B. The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:</p> <p>(i) Quacquarelli Symonds (QS)</p> <p>(ii) the Times Higher Education (THE) or</p> <p>(iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai). Note: The Academic score as specified in Table 3, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.</p> <p>2.
