

Prof R S Rathore, Registrar (SVSU) welcome the Hon'ble Vice Chancellor and Chairman of Planning Board and all members for participating in the meeting and briefed about the role and compositions constitution of Planning Board and about its advisory responsibility in development of the University particularly in respect of the standard of education and research in the University.

The agenda items of the meeting were taken up as follows:

### PB/01/01: To report vision document of the University and major accomplishments

The Hon'ble Vice-Chancellor also extended a warm welcome to all the members for attending 1st meeting of the Planning Board and apprised the milestones achieved during the journey of University since its inception. He briefed about the Vision document of the University which is based up on the youth aspiration survey conducted across the 1600 sample survey and 1400 online sample survey which tried to explore the youth's preference towards various sectors of economy and the associated job roles therein. Sports appeared to be most preferred by the students, whereas senior students preferred Automobile, IT/ITES and Healthcare. The graduates and post graduates, opted for IT/ITES followed by BFSI, Automobile and Healthcare. The ITI students mostly preferred construction sector. 77% student agreed to relocate to continue their education. The vision document of the University covers the prospective 10 years of planning.

He also briefed about the journey of creation of University LOGO through open competition and explained its significance which reflects the vision of the University. It was informed that the foundation stone of the university was laid by Hon'ble Prime minister on 19th Nov 2018 and briefed about the progress made by the University in terms of Infrastructure. He also apprised the Skill Integrated Model of SVSU which is in alignment with NSQF. Dual Educational Industry Integrated Model has received appreciations from both industry and other Government departments. The Academic structure of the university was also presented to members for information that in all academic programmes 60% credits are assigned to skill component and 40% credits to general education components. AICTE and UGC approvals of university programmes was informed. Vice Chancellor also briefed the members about the current status of all the off-campus program and new In-campus AICTE approved program from July 2021 and other short courses being conducted at CSA. Special mention of Girls student achievement by SVSU during at All India Level wielding competition was made by him.

He also informed about the unique initiative of university by introducing a course on Folk art Banchari in which students are getting training on the instruments, music and they are now earning their livelihood with new skill set learnt in the university.

Vice Chancellor informed that the University conceptualized an innovative campaign "Kaushal se Rojgar tak" through one of popular news channel to highlight university programmes across the State, which resulted in over 5000 applications for admission in the university despite the effect of Covid pandemic. It was informed to members that university has adopted of E office to speed ups the work, bring transparency and reduce the net requirement of stationary. The university initiative during the lockdown like conduction of online teaching, organizing national and international webinars and programmes like 4 lakh meals and 20 lakh masks was brought to the notice of members.

### PB/01/02: To inform about the Academic programmes of the University approved for academic session 2020-21.

Prof Rathore briefed about starting of an integrated B. Voc programme with a vertical mobility option towards B.Tech. This B.Tech. programme will be compliant to AICTE Model Curriculum and the student will have option for multi point exsit with appropriate diploma/degree. Besides regular programmes, there will be a large emphasis on running short term programmes which will be 4 times to the number of students enrolled under regular programmes.

### PB/02/03: To report the progress made by the University infrastructure development

Mr Ramneek Huda, the consultant Architect of IrconISL presented the progress in infrastructure development of university.

Mr Ravinder Rana congratulated the SVSU leadership and team for the considering him to be the part of Planning Board members. He insisted for more technology intervention in all the initiatives of the University. He also proposed to set up a full-fledged IT enabled incubation centre and hardware, networking lab at Dudhola Campus from corpus of Concentix Pvt. Ltd. Mr Rana also advised to have a controlled usage of Artificial Intelligence and Machine learning capabilities of University and focus on more job oriented courses, he also advised to focus on Health Sector. Mr Ravinder Rana also emphasised to focus more on courses that have scale, where large numbers can be trained for prospective employment and livelihood.

Mr Jasmeet Singh, from IndusInd bank congratulated for the development of the University. He insisted for continuous gain of knowledge and skills by University for employment. He informed there is a vast opportunity in retail sector that can be encashed by the University for the employment of students and also offered to help the University through CSR Funding of corporates. He also showed his willingness to starting short term courses in Retail banking along with long term program in Banking & Finance, in the similar lines that of HDFC programs.

Ms Veenu Jaichand Associate Partner, Ernst & Young Pvt. Ltd. congratulated for development of the University and expressed happiness on the uniqueness and aspirational programs of SVSU.
