General Instructions for Applicants

1. The Candidate must be a citizen of India.
2. This is a **ROLLING ADVERTISEMENT** and applications are invited throughout the year.
3. Candidates will be allowed to update their qualifications, experience and other credentials in the application throughout the year.
4. When a sizable number of applications (as decided by the authority) are received, a cutoff date will be announced on the university's website considering the requirement job role/QP-wise.
5. A notification to update the applications will be given through the university's website/email/SMS fifteen days prior to that cutoff date.
6. All qualifications and experiences will be considered up to the cutoff date and after this date, applications will be sent for scrutiny.
7. The candidates are advised to satisfy themselves about their eligibility before applying for an assessor for a job role in a particular sector. A valid Certified Assessor Certificate issued from Certifying Agency is must along with other conditions laid down for qualification and experiences in Industry/Sector and Assessor Experience.
8. No TA/DA shall be paid to the candidates for attending the interview/any other assessment test.
9. The prescribed essential qualifications and experience are minimum and mere possession of the same does not entitle a candidate to be called for interview.
10. The University reserves its right to place reasonable limits on the total number of candidates to be called for an interview. The number of such candidates will be decided by the Committee constituted by the University for the purpose.
11. Applications not accompanied with necessary/required documents, self-attested copies of degrees/certificates/mark sheets/experience certificates/category certificate/reprints (if applicable) issued by the competent authority will be considered as incomplete and rejected.
12. No enquiry in this regard will be entertained.

13. Canvassing in any form will lead to cancellation of candidature.
14. In cases of any disputes, any suit or legal proceedings against the University, the territorial jurisdiction shall be restricted to the District Court Palwal, Haryana and Punjab and Haryana High Court, Chandigarh.
15. The University reserves the rights not to empanel assessors for any Job Role/Sector.
16. Separate Application forms and Application Fee should be submitted if applying for more than one job role/QP/sector along with requisite details.
17. Candidates must regularly visit the university website (www.svsu.ac.in) for all the details and updates related to further processes.
18. In case of any inadvertent mistake in the process of recruitment/selection, if detected at any stage even after the issue of empanelment order. University reserves the right to modify/withdraw/cancel any communication sent to the candidates.
19. The initial period of empanelment will be for 1 year and can be extended further on the basis of performance and as per University norms.
20. Candidate must have the following: -
 - Complete knowledge of Vocational Education, Skill Development ecosystem and its stakeholders.
 - In-depth knowledge and understanding of National Occupational Standards and National Qualification Framework.
 - Overall sectorial and industry knowledge ability to analyze/collate demands and prepare a sustainable plan/models of skill programs/courses/work-study model and skilling framework.
 - Candidates must be a certified assessor of NSDC/SSC (relevant) and must have a valid certification ID.
 - Candidates must have experience of assessment of NSQF aligned Job roles/QPs.
 - Candidates must not be blacklisted by MSDE/NSDA/NSDC/SSC.
