Certificate of Experience (only for the full-time teaching experience on a Teaching Post i.e. Lecturer, Assistant/Associate Professor, HoD, Director, Dean etc. in any recognized Higher Educational Institutions) with clear mention of Designation, Time-period & Pay scale/Band with AGP, which must be supported with Salary slip/PF statement/ Form 16/ Bank Statement or any other valid proof of salary paid as claimed in the certificate.
