Auction for Scrap at SVSU - Gurugram

Invitation is sought from reputed agencies / scrap dealers for auction of SCRAP lying at the Transit office SVSU Gurugram in Physical form on 28.02.2022 at 11:00 am at Transit campus, SVSU (Plot No. 147, Sector-44, Gurugram). The following schedule shall be followed:-

Date of Inspection of site – Gurugram:	24.02.22
Date of Auction at Gurugram:	28.02.22

Items to be sold as Scrap

1. Broken Plastic
2. Card board ("GATTA")
3. Broken Iron pipes, pieces and other waste
4. Broken wood / board pieces etc.

General Terms & conditions:

- 1) The Vendor is required to inspect the scrap and submit his highest auction bid in writing along with name, address, phone number.
- 2) The auction will be done in presence of at least 2 committee members and one person from accounts present.
- 3) Once the auction is completed and committee is agreeable on the highest bidder, arrangements will be made to get the scrap material weighted in presence of the committee members or their representatives.
- 4) The weighing process will completed on the same day or any date nearby and will be intimated to the highest bidder.
- 5) Once the weighing has been completed the vendor will have to give in writing the total weight of each item and total price for each item. On the basis of grand total of the price the vendor will prepare a DD in the name of Shri Vishwakarma Skill University and submit not later than TWO working days to the Accounts.
- 6) Once the DD is encashed SVSU will issue Gate Pass signed by the committee members and permission will be given to the vendor to lift the material at his own risk and cost out of the premises of SVSU.

- 7) In case the highest bidder fails to provide a DD for cost of the scrap as decided, the scrap will be sold to the second highest bidder after approval of the Competent Authority.
- 8) The agency / scrap dealer will have provide a cheque or DD in favour of SVSU for Rs 2000/ as EMD, which shall be returned or adjusted once the deal is completed with the finalised bidder.
- 9) In case the finalised bidder fails to make payment for the finalised sale price of scam the EMD will be forfeited.
