The applicants who are unable to download the admit card due to any reason may obtain the provisional admit card on Mar 04, 2022 from 9:30 am to 3:00 pm at the University transit office 2nd & 3rd floor Plot No 147, Sector-44 Gurugram. Such applicants need to bring along their Application Form/ID, two photographs and valid ID proof having clear recent photograph.

3. As already notified, it is mandatory to qualify (*40% marks for Gen & 38% for the SC/PWD*) this test, failing which will lead to disqualify for further process of selection.

4. Please note that all applicants who had applied for the respective post(s) are being called for appear in the written test without verification and ascertaining the eligibility. All applicants are advised to satisfy themselves w.r.t eligibility for respective
