Please refer to your application for the Post of Assistant Professor in Food Technology against Advt. No. SVSU/2022/Estt./T/006. On the basis of the information filled in the application form and the documents attached, the applications have been scrutinised and the scrutiny report is attached herewith at Annexure-A.

2. As already notified, it is mandatory to qualify (*40% marks for Gen & 38% for the SC/PWD*) the written test for appearing in the Interview/ Presentation. Accordingly, all applicants declared provisionally eligible, as per attached scrutiny reports (subject wise) are required to appear in the written test scheduled to be held on Dec 10, 2022 at 11:00 am at University Transit office Plot No. 147, Sector 44, Gurugram.
3. The admit card for this test will be issued on Dec 10, 2021 at 10:00 am onwards at the venue of the test. Applicants need to bring along valid Identity proof having recent clear photograph. The duration of the test will be 2 hrs 30 minutes. This test will comprise of 100 MCQs out of the latest UGC prescribed NET syllabus.
4. Further, it is clarified that the eligibility of the applicants as per scrutiny report is provisional as the same has been determined on the basis of the information filled by respective applicant, without verification and thus subject to the verification of the certificates/ testimonials in support of the eligibility as per conditions already specified. If any information is found to be incorrect at any stage during the selection process, the respective application will summarily be rejected.
