



## MINUTES OF THE 23<sup>rd</sup> MEETING OF EXECUTIVE COUNCIL (Emergent)

The 23<sup>rd</sup> meeting of the Executive Council (Emergent) of Shri Vishwakarma Skill University, Haryana was held on 28.06.2022 at 04:00 PM through physically / online mode using ZOOM meeting application.

At the outset, the Hon'ble Vice-Chancellor & Chairman extended welcome to all the members for attending 23rd Executive Council Meeting (Emergent) on a short notice. The purpose of the meeting was informed to the Council and he also informed that as the nature of Agenda was confidential and related to service of an employee of university the Agenda was not circulated on mail. It was also informed that another purpose to bring table agenda for the meeting was to add any last minute update in the case.

The Hon'ble Vice-Chancellor and Chairman extended a special thanks to all the members for sparing their valuable time for this crucial meeting.

With the permission of Chair, the table agenda was presented by the Registrar.

**EC/23/01: To take a decision on appointment of Mr. Sanjeev Tayal on the post of O.S.D. to Vice Chancellor in view of the relevant facts including the verification report received from the Directorate of Higher Education, Sikkim; legal advice sought on the matter from Adv. Hitesh Pandit, Additional Advocate General, Government of Haryana and the letters/ mails/ replies of the employee.**

The Council was informed that Mr Sanjeev Tayal is working as OSD to VC based on appointment letter issued vide Ref. no. SVSU/20/Estt./1522 dated 26/02/2020. He got the benefit of marks for M.A (Psychology) from Eastern Institute of Integrated Learning Management University (EILIM University) during the selection process. During the verification of his educational credential the Directorate of Higher Education, Education Department, Government of Sikkim vide Ref No 47/DIR/HE/EDN/EILMU dated 27.05.2022 informed that -

***“Master of Arts/M.Sc. Psychology is not UGC/DEC recognized course for EILM University, Sikkim. The enclosed mark sheet copy of Sanjeev Tayal, bearing enrolment no. EILMI/10/S57179 is not valid/genuine.”***

The University sought clarification from Sh Sanjeev and took a legal opinion from Mr Hitesh Pandit, Additional Advocate General, Government of Haryana.

The Additional Advocate General opined that:

*“..... given reasons in my considered opinion, an employee who had secured the appointment on the basis of the fake/ingenuine qualification certificate/caste certificate/experience certificate would not be entitled to the protection provided under Article under 311 of Constitution of India and the further course action for the Competent Authority is to evoke clause No.1 and 3 of the appointment letter dated 26.02.2020 issued in favour of the Sh. Sanjeev Tayal (working as OSD to V.C.) and his services be terminated.*

However, by following the principles of Natural Justice that, **no one shall be condemned unheard i.e. there must be fairness on the part of the deciding authority.**, it would be advisable to the Competent Authority to provide an opportunity of personal hearing to Sh. Sanjeev Tayal (working as OSD to V.C.) at defend his case as termination of his service can be matter of life and death..."


The whole matter along with the verification report received from the Directorate of Higher Education, Sikkim; legal advice and the letters/ mails/ replies of the employee were presented as per the Annexures in the Agenda of the meeting to the Council for a decision.

The Council appreciated the action taken by the university in the case where Sh Sanjeev has been given enough opportunities to prove the validity/genuineness of his Master Degree including a personal hearing by Hon'ble Vice Chancellor.

However, as this a matter pertaining to service of an employee of university, his request of personal hearing by EC to be considered. The EC further authorised Vice Chancellor to give him another personal hearing with VC on behalf of EC to prove the validity/genuineness of his Masters of Arts/ M.Sc. (Psychology) degree bearing Enrolment No. ELIIMU/10/S/57179 issued by ELIIM University, Sikkim as no response was received from the EIILM University. The EC decided that Sh Sanjeev be given maximum six weeks' time to prove the validity of his Master's Degree issued by EIILM University from the date of issuing a letter by the University in this regard.

It was decided by the Council that any further decisions on the matter will be taken by the EC based on the report of personal hearing.
