Guidelines for payment of Honorarium: -The Honanrium shall be paid for RPL project only and it cannot be claimed for other University programmes.

1.Guest Faculty-The Honorarium to Guest Faculty will be paid as per the UGC guidelines i.e., Rs.1500/- perlecture subject to a maximum of Rs.50,000/- per month and shall be abided by the UGC guidelines.

2. **Adjunct Faculty-**Adjunct faculty will be paid an honorarium of Rs. 1000/- (Rs. One Thousand Only) per lecture to a maximum of Rs. 4000/- (Rs. Four Thousand Only) per day subject to a maximum ceiling of Rs. 80,000/- (Rs. Eighty Thousand Only) per month shall be abidedby the UGC guidelines.

3. Subject Matter Expert: Candidates having vast experience in the field shall be empaneled as Subject Matter Expert and will be provided an honorarium of Rs. 2000/- (Rs. One Thousand Only) per lecture to a maximum of Rs. 5000/- (Rs. Five Thousand Only) per day subject ba maximum ceiling of Rs. 50,000/- (Rs. Fifty Thousand Only) per month.

4. Visiting Faculty: Deserving and suitable candidates shall be empaneled as Visiting Faculty and will be paid an honorarium of Rs. 1500/- (Rs. One Thousand Only) per lecture to a maximum of Rs. 4500/- (Rs. Four Thousand five hundred Only) per day of service subject a maximum ceiling of Rs. 50,000/- (Rs. Fifty Thousand Only) per month.

Empaneled Guest Faculty/Adjunct Faculty/Subject Matter Expert / Visiting Faculty will not be given the benefit of allowances, pension, gratuity and leave, etc. as admissible to the regular teachers.

Note:

1. Candidates are required to bring latest bio-data along with one self-attested Copy

of all relevant testimonials and certificates along with the original testimonials and certificates at the time of interview.

2. Industry experienced /retired professionals are encouraged to apply, who are having flair for teaching.

3. Venue of Classes under this project will be held at Skill Development Centre - JBM, Faridabad and it may be held at any designated place decided by the University on Sunday/Non-working days.

4. Teaching load to the empaneled faculty shall be assigned /allotted on the actual need of the RPL course and as and when required.

5. No claim for extension of the empanelment shall be entertained under any circumstances.

6. Performance shall be the key criteria for the empanelment. In case of Non- Performance during the empanelment, University reserves the right to terminate the empanelment at any stage of the time without assigning any reason.

7. No TA/DA shall be paid for attending the interviews as well as for taking lectures.
