Instructions to the Applicants

1. Eligible & interested candidates can send their applications, mentioning the post applied for, advertisement no, their qualification/ specialization & experience in the above e-mail or can send it by post in the above address. Candidates are requested to provide their active e-mail Id./Mobile no./Phone no. Applications without complete information/ supporting documents may not be considered. Shortlisted candidates will be informed by email for an interview.
2. Candidate needs to submit all relevant documents in support of claims for UPSC/PSC/SSC Exam qualification.
3. The appointments will be purely temporary in nature and no claim for regularity at any stage in any condition shall be entertained by the university. No TA/DA will be given for conducting offline classes.
4. Before applying for the post, applicants are advised to go through the Essential/Desirable Qualifications and other general instructions carefully and satisfy themselves with their eligibility and candidature. Later on, no inquiry in this regard will be entertained.
5. The contractual recruitment shall be on the basis of merit through all India advertisements and selections by the duly constituted Selection Committee.
6. The process of selection may be by a presentation/ seminar/interview or a combination thereof
7. All empanelment made shall be provisional and subject to verification of certificates through proper channels. The University shall verify the documents and antecedents of the applicant at the time of document verification or anytime during the tenure of the service. In case it is found at any point of time that any documents/information submitted by the candidate is false or the candidate has suppressed any relevant information, the services of the selected candidate shall be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of false certificates.
8. *Under the term 'good academic record' the candidate must have obtained a minimum of 55% marks (or an equivalent grade in a point scale, wherever the grading system is followed)
9. A relaxation of 5% shall be allowed at the Bachelor's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness. (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure. 3.5. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September 1991. 3.6 A relevant grade which is regarded as the equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
10. Any type of corrigendum/addendum/amendments/notice/updation etc. related to this advertisement shall be uploaded on the University website www.svsu.ac.in only. Further, the University will not send any further information/call letters by post/newspapers. The University will not be responsible for invalid/wrong email ID and Mobile No. mentioned by the candidates. Therefore, it is the responsibility of the candidate to mention the correct contact details and regularly check their e-mail, SMS and SVSU website www.svsu.ac.in for updates.
11. Mere fulfilling eligibility conditions will not entitle any candidate to be called for an interview. Stringent criteria like the number of times appeared in an interview with UPSC Civil Services, the number of times cleared the UPSC Civil Services Mains Examination/Preliminary Test, Teaching experience in UPSC-focused Coaching institutions (with proven results of the selection of enrolled candidates in UPSC Civil Services Examination), publications in the UPSC related syllabus will be applied for short-listing the candidates. The University reserves the right to place a reasonable limit on the total number of candidates to be called for an interview.
12. The University requires a particular specialization; therefore, the University reserves the right to shortlist/select candidates as per the requirement of the specialization/research area.
13. The University reserves the right to withdraw any advertised post at any time without assigning any reason. The right is also reserved with the University either to fill or not to fill the post and the decision of the University in this regard will be final.
14. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issuing an appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the applicant
15. If the services of the selected candidate are not found satisfactory at any stage, his/her services may be terminated forthwith without assigning any reason
16. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the University shall be final.
17. All candidates are required to deposit & a demand draft of Rs 500/- drawn in favour of SVSU SKILL INNOVATORS FOUNDATION for each post, they apply. However, the SC/ST/PWD/Women candidates are exempted from the application fee.
18. It is the responsibility of the candidate to assess his/her own eligibility for the post for which he/she is applying in accordance with the prescribed qualification, experience etc. In case the candidate who do not meet the minimum eligibility criteria and still apply will do so at their own risk and cost. Please note that the University is not responsible for incorrect entries and fee once paid will not be refunded in any circumstances.
19. Any change of address from the one given in the application form should be immediately communicated to the University.
20. The applicants serving in Government/Semi-Government organizations/Public Sector Undertakings/Autonomous Organizations must upload the NOC issued by their employer. In case the candidate is unable to get NOC from his/her employer due to whatsoever reasons at the time of application, he/she may apply online as advance copy and NOC may be submitted at time of interview, failing which his/her candidature will not be considered and he may not be allowed to appear in the interview.
21. Candidates shall have to produce original documents at the time of appearing in interview.
22. Canvassing in any form will lead to cancellation of candidature.
23. The University reserves the right to place the curriculum vitae of any person for any post for the consideration of Empanelment Committee; to consider "in-absentia" or interview through "Video Conferencing".
24. The candidate shall attend the interview at the designated place and time at his/her own expenses.
25. In case of disputes/suites or legal proceedings against the University, the Jurisdiction shall be confined to the Court of Gurgaon.
