Candidates are requested to provide their active e-mail Id. /Mobile no. /Phone no. Applications without complete information/ supporting documents may not be considered. Shortlisted candidates will be informed by email for an
- Candidate needs to submit all relevant documents in support of claims for UPSC/PSC/SSC Exam qualification.
- The appointments will be purely temporary in nature and no claim for regularity at any stage in any condition shall be entertained by the university. No
- Before applying for the post, applicants are advised to go through the Essential/Desirable Qualifications and other general instructions carefully and satisfy themselves with their eligibility and candidature. Later on, no inquiry in this regard will be entertained.
- The contractual recruitment shall be on the basis of merit through all India advertisements and selections by the duly constituted Selection Committee. 5
- The process of selection may be by a presentation/ seminar/interview or a combination thereof All empanelment made shall be provisional and subject to verification of certificates through proper channels. The University shall verify the documents and antecedents of the applicant at the time of document verification or anytime during the tenure of the service. - *Under the term 'good academic record' the candidate must have obtained a minimum of 55% marks (or an equivalent grade in a point scale, wherever provisions of Indian Penal Code for production of false certificates.
- A relaxation of 5% shall be allowed at the Bachelor's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness: (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for recruitment.
