Subject: Regarding the filling of online Re-Evaluation form for the End Term Semester Examination December 2022 & January 2023. (Regular & Re-appear)

It is to inform all the students appeared in the End Semester Examination December 2022 and January 2023(Regular/ Re-appear) that the re-evaluation form has been opened. The students can apply through the link published on the University website. The last date of re-evaluation form is **01.05.2023 (10:00 AM)**. No re-evaluation form will be accepted after the last date.

All the students are advised to read carefully the following:

1. A student can apply for Re-evaluation form, who has obtained more than 20% and less than 70% marks in a particular theory papers excluding sessional/ internal marks

2. The student has to pay the prescribed fee directly to University account (details given below) and upload the screen shot of the transaction made in the online mode. The form will be processed after the verification of the amount paid. If the transaction details given in form found wrong, the form will be treated as cancelled and fee is not refundable. The students are advised to visit University website regularly for updates.

3. If student does not fulfil the eligibility to fill the re-evaluation form, even then He / She fills the re-evaluation form, the form will be rejected and the deposited fee will not be refunded.
