At the outset, the Hon'ble Vice-Chancellor & Chairman extended a warm welcome to all the members for attending 27<sup>th</sup> Executive Council (Emergent) Meeting through physically/ online mode using Zoom meeting application. The Hon'ble Vice-Chancellor and Chairman extended a special thanks to all the members for sparing their valuable time for attending the emergent meeting on a short notice.

The agenda items of the meeting were taken up as follows:

**EC/27/01: TO CONSIDER AND APPROVE RECOMMENDATIONS OF THE ESTABLISHMENT COMMITTEE FOR RECRUITMENT OF ASSISTANT ON DIRECT BASIS ADVERTISED VIDE ADVERTISEMENT NO. SVSU/2020/ESTT./NTC/010 IN COMPLIANCE TO ORDERS OF HON'BLE PUNJAB & HARYANA HIGH COURT**

The selection process for the post of Assistants on direct recruitment basis advertised vide Advt. No. SVSU/2020/Estt./NT C/010 [04(UR), 01-ESM-Gen, 01(SC), 02(BC-A), 01(BC-B), 02(EWS) ] was put on hold in compliance to orders of Hon'ble Punjab & Haryana High Court in CWP 4760-2022. It was reported that the stay in filling up the posts of Assistant in CWP-4760/2022 has been vacated by the Hon'ble High Court Vide CM No. 19614 of 2022. The Hon'ble court has vacated its order dated 10-03-2022 and allowed the selection process to continue regarding filling up 7 posts of Assistants in various categories and 02 posts of general category are to be kept vacant.

It was informed to the Council that there is an urgent requirement of office staff in the University as the operation of University is shortly going to be shifted to its main campus at Dudhola. The Executive council recommended that 07 posts to be identified as per roster register and Establishment Committee of the University should prepare a category wise merit list after adding marks of written test, Skill Test and socio economic criteria (wherever applicable). The Council authorized Hon'ble Vice Chancellor to declare the result of 07 posts as per recommendation of Establishment Committee. It was informed that the University will request Hon'ble Court to allow it to fill up 09 posts and in the meantime result of 07 posts will be announced as decided by the Council. These posts are filling up subject to final outcome of writ petition no. 4760/2022 titled as "Sumit and Anr. vs SVSU". As the writ is not finally disposed off only stay is vacated.

The representative from Finance Department requested that the promotional aspects of 02 clerks working in the University should be ensured as per direction of Hon'ble Court.

The meeting ended with a vote of thanks to the chair.
