- 2. The merit has been prepared on the basis of marks obtained in qualifying exam (academic marks) and Personal Interview (PI) with partner industry subject to meeting all eligibility conditions as stipulated in the prospectus of 2023-24.
- 3. The name of applicant in the provisional list does not entitle him/her for admission. The final admission will be made after original document verification at the time of counselling.
- **4.** Candidate must attend the counselling physically. Candidate who fails to appear as per the given schedule for counselling will not be considered for admission. No claim for seat due to late reporting or absentees will be considered.



- **5.** The candidate must read the prospectus 2023-24 carefully before attending the counselling.
- **6.** Any discrepancy in the provisional merit list may be brought into the notice of admission committee before commencement of the counselling.
- 7. The University may conduct another round of counselling in case any seat remains unfilled during first round of counselling.
