- 4) The name of applicant in the provisional list does not entitle him/her for admission. The final admission will be made after original document verification at the time of counselling.
- 5) Candidate must attend the counselling physically.
- 6) Candidate who fails to appear as per the given schedule for counselling will not be considered for admission. No claim for seat due to late reporting or absentees will be considered.
- 7) The candidate must read the prospectus 2023-24 carefully before attending the counselling.
- 8) Any discrepancy in the provisional merit list may be brought into the notice of admission committee before commencement of the counselling.
- 9) The candidate must bring all relevant original documents in support of their educational qualifications and category as mentioned in the prospectus along with one set of attested photocopies of all the documents at the time counselling.
