## About the University:

The Government of India has put a renewed focus around skilling and entrepreneurship development with an objective to enable social and economic progress. In line with this vision, the Government of Haryana has launched **India's first skill Development University - ShriVishwakarma Skill University (SVSU)**, through an act of legislation.

SVSU enacted as a Public University by Government of Haryana through an ACT No. 25 of 2016 vide THE SHRI VISHWAKARMA SKILL UNIVERSITY ACT, 2016. SVSU has adopted **Industry Integrated Dual Education Model (IIDEM)** for its NSQF aligned Diploma, UG, PG & Ph.D. programmes in Vocational Studies in line with German Dual Model vocation education pedagogy. University conducts these courses with active participation of industries in various business domains. This education model facilitates **"Earn-While-Learn"** and provides the students with the opportunity to enhance their qualification with flexibility of **entry and exit** into a programme.

This University has been established with an impetus to develop a skilling eco-system in order to bring skill to the mainstream education, build and promote respectability and acceptability for vocational programs. The University shall be taking up industry aligned courses with an objective to create an Industry acquainted workforce in emerging areas of economy e.g. Banking & Finance, Automobile, Manufacturing, IT &ITeS, Electronics, Apparel & Textiles, Health care, Construction, Agriculture, Transport and logistics etc. The University works with the Industry for developing **customized Certificate, Diploma, undergraduate, postgraduate and PhD programs**. SVSU's focus is also on Short Term Courses to **cater industry requirements in skilling space**.

Industry partner proactively participate from **end-to-end in programme conceptualization, curriculum design and development, students' selection process and On Job Training (OJT) in the industry premise for real time learning of the students**. SVSU pedagogy is hands-on exposure of students to acquire relevant skill sets required by the industry through OJT. Currently **SVSU has 40 % classroom and 60 % on the job training for its existing programmes**. Industry partner, faculty & students jointly find out solutions/insights in business problems by adopting proactive approach **through experiential learning**.

The University conducting **aM.Sc.MLT (Microbiology) 2yrs, B.Voc (Medical Laboratory Technology- MLT) 3yrs programme and certificate course's in Phlebotomy Technician and other areas**. University is also planning to start other courses of Medical & Allied Health Sciences in the field of Radiology, MRD etc. in the coming years.

It is very essential to train the MLT students which will play a crucial role in the Medical Diagnosis, Research & Development. They follow established procedures, standards, and guidelines, regularly calibrate and maintain lab equipment, and conduct quality control measures to detect and prevent errors. They also have critical thinking and analytical skills to interpret and analyze data. They play a crucial role in public health and disease prevention.

Therefore require Hi-end equipments, which use in the Medical Diagnostics under centre of excellence. All the Medical & Allied students will take training and skills.

## **SCOPE OF WORK**

1. Following Medical Laboratories with the Hi-end technology based equipment's to be establish under COE.

- Phlebotomy training centre
  - Microbiology Lab
  - Hematology Lab
  - Clinical Pathology Lab
  - Biochemistry Lab
  - Histopatology Lab
  - Molecular Research Lab
  - Radiology Lab (X, Ray, USG, CT & MRI Scan)
2. The University Students to be trained in their respective fields in the centre of excellence.
  3. Research & Development in the field of Medical & Allied Health Sciences.
  4. To provide services to the common people through test and research conducted in various Medical Laboratories in COE while providing training to students.
  5. To Recruit, Train and Deploy students enrolled in regular & short term programs of University.
  6. The COE will be used for the On Job Training (OJT) of the students on stipend basis.

All proposals for COE will be initially examined by a committee / constituted by the competent authority of the University.

All short listed proposals may be invited for a detailed presentation and further discussion before an expert committee.

A MoU will be signed with selected organizations to set up the centre on mutual agreed terms.
