2. *Students without bus pass will not be allowed to enter the bus. Bus timings will be informed separately.*
3. *Fee submission period valid from 09.02.2024 to 16.02. 2024. Fees to be submit by the students for three months at one time.*
4. *Bus service will be operational if minimum 30 numbers of students fees received for each route (Palwal, and Gurugram).*
5. *Apart from the University Transport Service, it is submitted that Haryana Roadways bus facility is also available from Bus Stand, Palwal to SVSU. University students may avail the bus facility of Haryana Roadways.*
