

The agenda items of the meeting were taken up as follows:

EC/38/01: TO REPORT THE JOINING OF THE VICE-CHANCELLOR OF SHRI VISHWAKARMA SKILL UNIVERSITY, PALWAL.

The Worthy Registrar informed the Council that Prof. (Dr.) Dinesh Kumar assumed the charge of Vice-Chancellor, SVSU, on 26/05/2025 (forenoon), in compliance with Notification No. HRB-UA-38(1)2016/3587 dated 24/05/2025 issued by the Governor of Haryana and Chancellor of Shri Vishwakarma Skill University.

The Registrar extended a warm and heartfelt welcome to the Hon'ble Vice-Chancellor and expressed sincere gratitude to the outgoing Vice-Chancellor, Prof. (Dr.) Sushil Kumar Tomar, for his invaluable contributions.

The Council considered and approved the joining report of the Hon'ble Vice-Chancellor.

At the end of the meeting, the Hon'ble Vice-Chancellor thanked all the present members and presented four discussion points for the Council's further suggestions and consideration.

- i. It was agreed that until the VC residence at the main campus is ready, HRA to be provided to the Vice-Chancellor as per rules or alternatively, a fully furnished residence-cum-camp office to be provided in Gurugram or Faridabad on the same terms as was done for the previous Vice-Chancellor Dr.Raj Nehru.
- ii. The Council was informed of a minor name change for Dr. Usha Batra, Skill Professor (CSE), and the university accepted her affidavit confirming all name variations refer to the same person.
- iii. As informed, the Council considered the launch of new academic programs from the 2025–26 session, including M.A. English, B.Sc. Mathematics and Computing (Hons. with Research), BCA, BCA(Honours) Specialization in AI&ML/Data Science/, BCA (Honours with Research), BCA+MCA (Integrated), and a PG Diploma in Semiconductor Device Packaging (PGDSDP).
- iv. The Council considered the deputation request of Ms. Suman Vashisth from Gurugram University for a suitable post at SVSU as per application received from the candidate.
