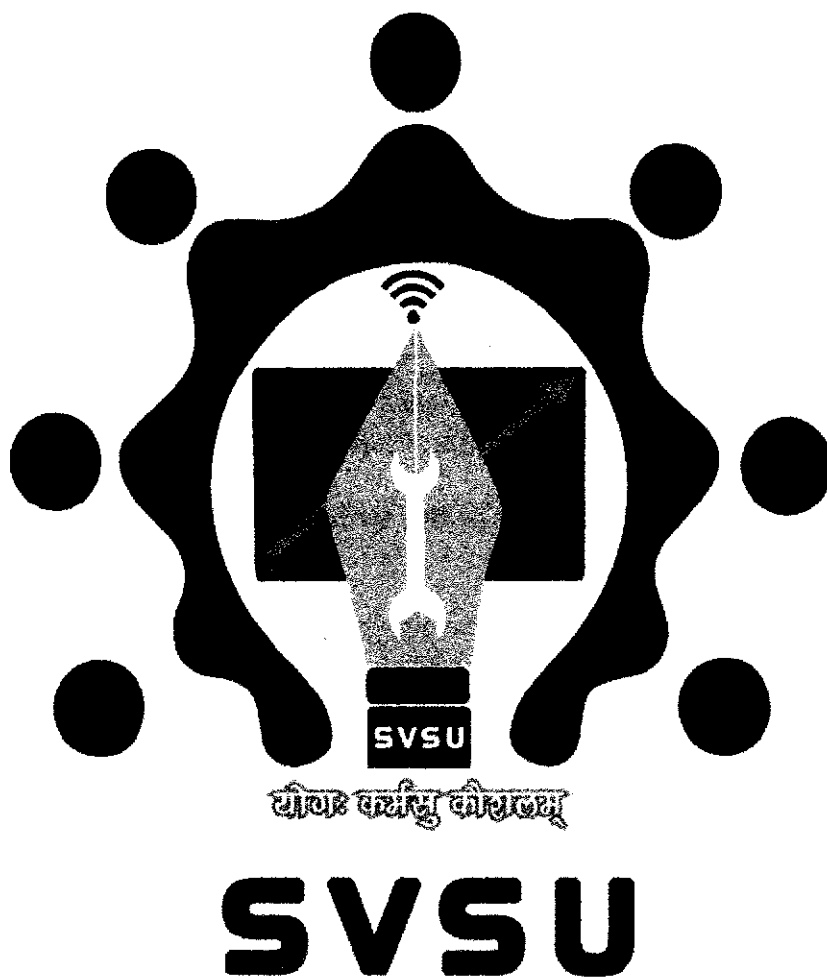

**The agenda items of the meeting were taken up as follows:**

**UC/07/01: PROGRESS REPORT OF THE UNIVERSITY–PRESENTATION BY VICE CHANCELLOR.**

At the outset, the Vice Chancellor welcomed all the members of the Court. He informed that Hon'ble Chancellor, vide letter no HRB-UA-38(4)-2017/2119 dated 18-03-2025 was authorized the Vice Chancellor to conduct the meeting.

With the approval of the Vice-Chancellor, the Registrar outlined the university's achievements: 43 programs (Diploma, B.Tech, Ph.D.), 33 Ph.D. scholars enrolled across skill-based departments, and robust industry linkages with 200 partners and 7-8 international collaborations. The Registrar also highlighted advanced facilities, including upcoming Solar, Robotics, and Welding Labs. It is apprised before the House that University is running the foreign language programs of the University.

The Registrar further introduced the Assessment and Certification Department (ACD), which oversees skill course training and assessments, including a 3-year project to evaluate 80,000 Haryana School Education Board students, a revenue-generating initiative. Additional ACD projects align with state government themes. The Registrar detailed the Guru-Shishya Kaushal Samman Yojana and the Pedagogy and Capacity Building Department.

The Vice-Chancellor appreciated the industry-supported curriculum and noted a meeting focused on micro-credential skill courses (1-3 credits), enterable into existing programs for added student value. He endorsed the feeder school system for skill development and urged more agreements with local industries.

**UC/07/02: CONFIRMATION OF THE MINUTES OF THE 06<sup>th</sup> MEETING OF THE COURT HELD ON 26.02.2024**

Registrar, SVSU presented the agenda and brought to the notice of the Council that minutes of the 6th meeting has been circulated among the members but no observations were received from any of the members.

**UC/07/03: TO CONSIDER AND APPROVE THE ANNUAL REPORT 2024.**

Registrar, SVSU presented the agenda and briefed about the Annual Report and its coverage/content.

Professor Randhir Singh Rathore, detailed about the conference organized at University for presenting papers in Hindi.

The Vice-Chancellor appreciated the concept of RPL being run in the University and programs launched on folks art like Banchari, and it was suggested to mention the name of committee members who have prepared the annual report.

Further, The Vice-Chancellor suggested to include more activities of students and fewer photographs, more coverage of research work and MOUs.

It is suggested that a master file is to be prepared for the annual report on LaTeX software and that is to be sent to faculty for updating the data from their departments from next year. He said that by using this software, we can save time and resources.

**The Court considered and approved a total budget of Rs 18118 .00 lakhs for the FY 2025-26 and Rs. 2000.00 Lakh for Guru Shishya Kaushal Samman Yojana for the FY 2025-26.**


**Comments from members:**

Prof. Ashok Aima recommended making academic audits mandatory and strengthening collaboration with schools and colleges, praising the university's progress and suggesting a vote of appreciation for the team led by founding Vice-Chancellor Prof. Raj Nehru. He also conveyed wishes to the Vice-Chancellor and mentioned that the university will progress under his visionary leadership.

Prof. Rajendra kumar Anayath emphasized focusing on Indian knowledge systems and suggested the university could lead in skill development nationwide.

Sh. Mohit Oswal proposed introducing Korean language courses, noting Korea's significant share of the global automotive market.
