At the outset of the meeting, Registrar & Member Secretary welcomed the Hon'ble Vice-Chancellor and all other W/Members of the 13th Skill Council. Registrar also extended a special thanks to all the members for sparing their valuable time for attending the meeting. The meeting started with the permission of the Hon'ble Vice-Chancellor. With the permission of the chair, proceedings of the meeting started. She invited Hon'ble Vice-Chancellor to share the progress of the University with all members.

Opening Remarks: Hon'ble Vice-Chancellor extended a warm welcome to all members for attending the 13th Skill Council Meeting through physical/online mode. On the request of members, the Hon'ble Vice Chancellor briefly shared his Academic and extensive professional journey. Members Congratulated to HVC about his contributions to various esteemed

organizations and his rich experience serving as Vice Chancellor in multiple Universities. Members endorsed that his vast knowledge, leadership, and insightful experiences will serve as a source of inspiration and motivation for all in the University.

The Honourable Vice Chancellor directed that Skill Council meetings should be conducted quarterly or at least twice a year to bring innovations, ideas, programmes to strengthen academics and ensure effective monitoring and implementation.

The agenda items of the meeting were taken up as follows:

SC/13/01: PROGRESS REPORT OF THE UNIVERSITY – PRESENTATION BY VICE CHANCELLOR

Registrar, Prof. Jyoti Rana presented the agenda before the council.

HVC asked Registrar to present the progress of the university in brief. A brief yet comprehensive introduction was given by the Registrar on the wide range of skill-based and academic courses being run at the university, designed to meet the evolving demands of industry and society. The Registrar also discussed the newly launched programmes along with their approved intake capacity, reflecting the university's continuous efforts to expand learning opportunities. The progress made by the university was also highlighted, including the signing of multiple MoUs with reputed industries across various sectors to strengthen industry-academia collaboration, facilitate hands-on training, and enhance employability. Significant strides in infrastructure development were also shared, with major facilities now completed or nearing completion, further supporting the university's mission to deliver quality education and skill development. Registrar informed about the progress of ACD, PCB, DSW, Affiliation and Sr. Sec. School.

The Hon'ble Vice Chancellor advised a reconsideration of the M.A. English programme, suggesting that it should be redesigned to align with the skill-based approach as outlined in the latest UGC guidelines. He emphasized the need to integrate practical and industry-relevant skills into the curriculum to enhance the employability and relevance of the programme in today's competitive job market. Prof. Ravi Pratap Singh, IIT Delhi has proposed the introduction of a mandatory non-credit foreign language course for all students. HVC also endorsed the same.



The Hon'ble Vice Chancellor emphasized the importance of foreign language proficiency and directed that learning at least one foreign language should be made compulsory for all students of the university.

Mr. Jaikant Singh from NSDC also emphasized the importance of foreign language proficiency for students. He also suggested to start COE in disaster management.

Prof. Rishipal, Dean, SFMSR, suggested that a dedicated Department of Foreign Languages should be established in the university to promote and strengthen the importance of foreign language education. HVC asked Dean, SFASH to explore department of foreign languages. He emphasized that such a department would not only facilitate structured learning but also equip students with the linguistic skills necessary to thrive in global academic and professional environments.

SC/13/01: TO INFORM THE COUNCIL ABOUT THE RECEIVED LETTER FROM SDIT REGARDING FOUR-YEAR B.VOC & 2-YEAR D.VOC COURSES OF SHRI VISHWAKARMA SKILL UNIVERSITY, RELATING DURATION OF COURSES AND OPPORTUNITIES AFTER COMPLETION OF COURSES, AND SEEKING GUIDANCE ON THE MATTER.

It was brought to the notice of the council that a complaint was lodged regarding the duration of B.Voc and D.Voc courses at Shri Vishwakarma Skill University. The complainant, an anonymous parent, raised concerns that the B.Voc courses (Mechatronics and Robotics and Automation) were listed as 3+1 years and the D.Voc (Industrial Electronics) as two years, which contradicted the guidelines of regulatory bodies. An inquiry committee was constituted in this regard, which made the following observations.

1. The said programs duration is in contradiction with the guidelines of the governments statutory bodies. The programme durations is not as per the guidelines of UGC/AICTE/NCVET and the programs B.Voc (Mechatronics) and B.Voc (Robotics and Automation) are not approved by AICTE and these programs are not being offered as per guidelines of UGC. also D.Voc (Industrial Electronics) is not approved by any statutory body (AICTE/NCEVT) as there are not standalone guidelines for two years D.Voc released by AICTE/NCVET.
2. This is to note that as mentioned above the B.Voc Honours with Research is not in compliance with government guidelines.
3. The duration of a diploma program is 3 years hence students passing 2-year D.Voc program are not at par with 3-year diploma programs and will not be eligible to apply for jobs for which eligibility is diploma engineering (3 years)/diploma (3 years).

The HVC briefed the above matter, which was subsequently discussed. The HVC directed all Deans to ensure compliance with the National Education Policy and emphasized that the University shall resolve the issue internally, if any with the guidance of senior professors of the University.

The Skill Council noted and approved the same.

SC/13/02: DISCUSSION ABOUT TRANSIT OFFICE, GURUGRAM.

The Hon'ble Vice Chancellor shared the status of Transit Office of SVSU and suggested that it must be transformed into a dynamic, efficient, and student-centric unit that actively caters to the evolving needs of both learners and industry. He further directed that new, high-impact, skill-driven programs be identified and introduced in alignment with current industry demands and future workforce requirements.

HVC also suggested to start finishing school and 2/3 days-one week programmes should be kept mandatory for all students in transit office. HVC also informed that the university is going

to execute MoU with Department of Future, Government of Haryana to collaborate and work on innovation and ideas.

The Registrar also suggested that the Management Department, in collaboration with the Industry Integration Cell, could initiate MDPs, considering the presence of industry partners. The HVC directed the Management Department to begin the MDPs in coordination with the Industry Integration Cell of the University.

The Skill Council noted and approved the same.

In addition to the points mentioned above the following directions and suggestions were shared in the meeting:

The Honourable Vice Chancellor expressed his view that the University should consider launching a Ph.D. program specifically designed for industry professionals, while strictly adhering to UGC norms. He emphasized that such an initiative would not only strengthen the University's academic-industry linkage but also contribute significantly to its growth and advancement.

Students suggestions:

Ms. Vidhi (Sem 4th Bachelor of Hotel Management) Student Nominee inquired whether it is possible to pursue two dual degree programs simultaneously.

It was suggested and directed by the Skill Council that academic programs can be conducted in two shifts and a flexible and coordinated timetable may be developed so that more students can take advantage of dual degree options while maintaining academic and training efficiency. She also suggested to include sign language in the programme and emphasized that including sign language would promote inclusivity and empower individuals with communication barriers. HVC asked Dean, SFASH to explore the possibilities of starting programme in sign language.

Ms. Shakshi (2nd Sem B.Sc Yoga) Student Nominee suggested that along with foreign language programs, there should also be skill-based value added programs. On the request of the student members, the Hon'ble Vice Chancellor directed the Dean, DSW to organize more number of programmes in the University campus.

Mr. Chetan Tewatia Sem 2nd M.Tech (RBA) emphasized the importance of instilling discipline among students and suggested that the university should introduce courses aimed at developing tolerance and emotional resilience. He highlighted the need for value-based education that not only imparts academic knowledge but also nurtures ethical conduct, patience, and mutual respect.

The HVC directed SFASH to initiate and conduct a one-week programme for all students of the university.

Other Suggestions by HVC

The HVC emphasized that all academic programmes must be aligned with the National Education Policy (NEP) to promote holistic, multidisciplinary, and future-ready education. He further directed that the approved syllabus should bear the signatures of all committee members

and the concerned faculty members, thereby ensuring transparency, accountability, and collective responsibility in the curriculum approval process.

The meeting ended with a vote of thanks to the chair.
