EC/40/05: TO CONSIDER AND APPROVE THE RECOMMENDATION/MINUTES OF THE MEETING OF THE COMMITTEE CONSTITUTED REGARDING REVIEW THE EXISTING SYSTEM OF 33 EARNED LEAVE PER YEAR APPLICABLE TO ACADEMIC STAFF WITH NON ACADEMIC STAFF OF THE UNIVERSITY

The Executive Council considered and approved the recommendations/minutes of the meeting of the committee constituted to review the existing system of 33 days Earned Leave per year applicable to academic staff with non-academic staff of the university.

### EC/40/06: TO CONSIDER THE MATTER REGARDING PAYMENT OF LEAVE ENCASHMENT TO DR. RAJ NEHRU, FOUNDER VICE-CHANCELLOR, SVSU, PALWAL

The Executive Council considered the minutes of the meeting of the committee dated 13.09.2025 regarding payment of Leave Encashment to Dr. Raj Nehru, Founder Vice Chancellor, SVSU, Palwal and approved the same. The Council resolved that the reply of the letter of the Additional Chief secretary to Govt. Haryana, Finance Department, Chandigarh may be given according to the contents of the minutes.

In the end, the Vice Chancellor apprised the progress made in the university to the members of the Council. It was informed that the enhancement in cost for Construction Works of Phase-1 has been approved by the State Government. Now all the incomplete works will



be completed. The proposal of Rs. 300 Crores for 2nd phase is also under consideration of the State Government and will be approved in due course of time. Further, the Vice Chancellor brought out that a road from Delhi-Agra National Highway to the university near Baghola village will be constructed after obtaining the approval from State Government for the direct entry from Highway. The case for sanction of 48 posts for SVSU Senior Secondary School is in process and shall also be sanctioned by the State Government in near future. The role of the State Government is very commendable towards this university.

The Executive Council members congratulated the Vice Chancellor for the progress made in the university in a very short span.

The meeting ended with a vote of thanks to the chair.
