FC/10/01: PROGRESS REPORT OF THE UNIVERSITY- PRESENTATION BY VICE CHANCELLOR.

The Vice Chancellor apprised the Finance Committee that the Executive Council in its 41st meeting created 03 more Skill Faculties such as Faculty of Performing and Visual Arts, Skill Faculty of Medical and Allied Health Sciences and Faculty of Interdisciplinary Studies. Under these Faculties number of new programs are to be started from the session 2026-27. This University is in process to start MBA Program for Industry Professional in the weekend/evening.

FC/10/04: TO CONSIDER AND NOTE THE ANNUAL AUDITED REPORT OF FINANCIAL YEAR 2024-25.

The Finance Committee considered the Annual Audited Report of Financial Year 2024-25. One member Shri Tarun Gupta, C.A. suggested to review appropriately the grant received under Loan Scheme in the Balance Sheet.

FC/10/05: TO INFORM INCOME AND EXPENDITURE REPORT FOR THE FINANCIAL YEAR 2025-26.

The Finance Committee noted the Income and Expenditure Report for the Financial Year 2025-26 as presented in the agenda.

FC/10/06: TO CONSIDER AND APPROVE THE BUDGET FOR THE FINANCIAL YEAR 2026-27.

The Finance Committee considered the budget proposed for the Financial Year 2026-27 amounting to Rs. 22525.00 Lakhs for the University and Rs. 1700.00 Lakhs for Guru Shishya Kaushal Samman Yojana and approved the same.

FC/10/07: ANY OTHER ITEM WITH THE PERMISSION OF THE CHAIR.

(i). It was resolved in the Finance Committee that at least 03 Staff Cars may be purchased for the use of different officers of this University from the Self Financing Scheme as at present the University is having only one vehicle for the use of the Vice Chancellor. The University has to hire the vehicles from private vendors and has to pay monthly payment. Some-times the hired vehicles are not in use and staying idle but the University has to make the monthly payment to the vendor.
