1. Institute level Physical Counselling will be carried out as per HSTES Guidelines.
2. Interested eligible candidates who have not filled out the online application form but report at the time of on-the-spot counselling, they may submit the physical admission form for the vacant/left over seats **only after 12:00 Noon on September 11, 2026**.
3. If any seat remains vacant after concluding the on-the-spot counselling on **September 11, 2026**, against those vacant seats, interested and eligible candidates may report for **physical on-the-spot counselling on September 12 and September 14, 2026 (as the case may be), between 9:00 AM and 10:00 AM**.
4. **Seat allotment will be made on the same day strictly on the basis of merit.**

Important Instructions for students: -

Candidates are required to bring the following desired documents during the Physical Counselling:

1. Copy of Class 10th/ Class 12th/ ITI/ Diploma/ Graduation Marksheets/ Provisional Diploma/ Degree as per required eligibility (Original and Photocopy).
2. Valid Category Certificate, wherever applicable (SC/BC/PH/ESM/FF, etc.).
3. Income and Asset Certificate (FY-2026) issued by Competent Authority of Haryana Government where applicable (EWS/TFW/BC-A/BC-B categories)
4. Copy of Parivar Pehchan Patra (PPP) for Haryana resident candidates.
5. Copy of Aadhaar Card and EPIC (Voter Identity Card).
6. Four recent passport-size photographs.
7. Relevant supporting certificates, wherever applicable (EWS/KM/TFW/HGST/SGC, etc.).
8. Admission fee (published on university website Vide Ref. No. **SVSU/2026/AA/093, dated 01/08/2026**) through Credit/Debit Card payment at the University admission venue. (Cash and cheque payments shall not be accepted).
9. Candidates in Schedule Caste category having income less than Rs. 2.5 Lakh (Verified PPP and Income Certificate FY 2026) are eligible for Post Matrix Scholarship and exempted for depositing of fee. (only Security amount will be deposited).
10. Gap Year Affidavit (if applicable) & Copy of APAAR ID.
11. Medical Fitness Certificate issued by a Registered Medical Practitioner (Private or Government).
12. Migration Certificate, or Migration Certificate downloaded from Digi Locker along with a duly notarized affidavit, wherever applicable.
13. Character certificate

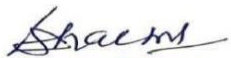
